We have several new vendors who may not know some of the policies for the store. So, I will try to put a few policies in the newsletter each month. This month I want let you know about booth sales. If you are putting a sale on your booth, it must be an "overall sale", everything in the booth will be on sale for whatever percentage you decide. The store will make sales signs for your booth if you wish, or you can. We do ask that you let us know and sign up on the sheet next to the cash register. You are also responsible for letting us know when you take your sale off and crossing off your info on the sale sheet. If you only want to have certain items to be on sale you will need to mark them down or attach a sale tag to them with a percentage off on the tag. We do have "sale tags" if you want to have a few. Secondly, if you bring your items into the store to mark, PLEASE clean up the area when you are finished. It is not fair to expect the staff to clean up after you! It would be preferable for you to clean and mark your items at home BEFORE bringing them into the store. Thirdly, we continue to have items come to the front with no tags, or not tagged in your booth. PLEASE, make sure you tag all items. Things that are not for sale should be tagged NFS with your number. If you have other questions or concerns, see Bonnie.
