Every so often I have to address the aisle issue!!!! **PLEASE stay within your front to back boundaries.** I know some of you feel I am "nit-picky" about things like this, BUT by fire code we

have to keep the aisles a certain width. PLEASE check your booths both down stairs **AND UPSTAIRS**, and move any items that are on the outside of the tape lines back into your booths. This includes items hanging on the outside of the pillars. If you need to rent more space so that everything fits, we can help you with that! Not only is it against fire code, but it is extremely hard to navigate down the aisles with a piece of furniture and items are getting knocked off of walls and broken.

**We have a dilemma!!! We are nearly full both upstairs and down! We may get to the point where you will need to leave sold and layaway items in your booths until they get picked up.** If it comes to that we will shorten the sold item pick-up time to one week. If we have room in the large work room, we accommodate layaways only in there.

If you are interested in a wire upper divider for your booth, please contact Scott and he can give you details.

**Reminders:**

- Anniversary rent credit! 10% off your rent during your anniversary month! ASK US!!
- If you cannot work your time due to weather or illness, please contact us as soon as possible (even at home)! We will try and reschedule with you
- Rent is due on the 1<sup>st</sup> of the month, payable up to the 10<sup>th</sup> and late with a \$10 late fee after that date
- A thirty day written notice, given on/before the 1<sup>st</sup> of the month, is required when you are shrinking down or vacating your booth at the end of the month. This applies when you are leaving after your initial six months OR at any other time after your 6 month commitment is over
- Ask the management about the "Finders Fee" bonus! Earn \$\$\$\$ off of the rent of your booth.
- Parking!!! Please move your car after you have unloaded so our customers can find a place to park
- Please keep the isles clear of your items so our after school helpers can do the vacuuming!

When you come in for your work shift there are two new documents we would like you to read. One is about using your time while working and the other is what to look for to help spot shoplifters.
