

# Frequently Asked Questions (FAQ)

## **1. Do you accept credit cards at Keeper's Corner LLC?**

Yes, we do accept VISA, MasterCard, and Discover Card. We do not accept American Express.

## **2. Do you do lay-a-way at Keeper's Corner LLC?**

Yes we do lay-a-ways. The lay-a-way item(s) need to total over \$50.00 and each item must be at least \$15.00. It is 1/3 down of the total cost of the item(s). All down payments are non-refundable. The lay-a-way item(s) must be paid in whole and picked up within 30 days.

## **3. Do we have gift certificates for sale?**

Yes, we do sell gift certificates. They can be purchased for almost any amount. There are no fees and they do not expire. Please ask KC Management for further information.

## **4. If I wanted to rent a booth at Keeper's Corner LLC, what do I need to do?**

You would need to talk to one of the KC Management personnel working at the store that day. You would need to explain that you were interested in renting a booth. You would need to decide which booth size booth or display you would like. You would explain to the KC Management what type of items you would like to sell. After receiving all of the information, you would need to sign a contract.

## **5. What are the prices of a booth or display at Keeper's Corner LLC?**

The prices vary with the size of the booth. The basic cost of a booth is \$3.00 per square foot of the booth area. Larger or smaller booths are available. There are some special prices for booths rented in the upstairs. There are also walls and displace cases available to rent.

## **6. Can you do consignments at Keeper's Corner LLC?**

Yes, we do consignments on some items that you want to sell. The type of items that we will take on consignment is limited to items as approved by KC Management. Normally it is limited to larger items such as furniture. Please ask about specific items. Consignments are done on a 65%/35% with the vendor getting 65% and KC getting 35% of the selling price. There is no fee until the consignment item is sold. Consignment contracts are normally for a 2 month period but can be extended with approval of KC Management.

## **7. How long is the minimum length of a contact with Keeper's Corner LLC?**

The minimum length of a contract is 6 months and then is on a month by month contract. A 30 day written notice must be given on or before the 1<sup>st</sup> of the month you wish to vacate your space, notifying KC that the Vendor is giving up the booth or display.

## **8. Do Vendors need to work at Keeper's Corner?**

Vendors are not employees of KC and are not required to work at the store. Vendors are encouraged to regularly work in their own rented booths and displays keeping them stocked, clean and displayed nicely. While in the store they can help other vendors and customers as they wish, but are not required to do so. Any help given to anyone is solely the choice of the Vendor. KC appreciates the help given to customers or other Vendors but will not compensate said Vendor for doing so.
