**Those of you with cases!!! PLEASE** turn your price tags right side up so your price shows! We really do not have time to unlock a case just so a customer can see the price. Many customers have told us that if they cannot see the price, they figure they cannot afford it and **WILL NOT** ask for help. You are costing yourself sales!!!

**Reminders:**

- **Anniversary rent credit! 10% off your rent during your anniversary month! ASK US!!**
- **If you cannot work your time due to weather or illness, please contact us as soon as possible (even at home)! We will try and reschedule with you**
- **Rent is due on the 1<sup>st</sup> of the month, payable up to the 10<sup>th</sup> and late with a \$10 late fee after that date**
- **A thirty day written notice, given on/before the 1<sup>st</sup> of the month, is required when you are shrinking down or vacating your booth at the end of the month. This applies when you are leaving after your initial six months OR at any other time after your 6 month commitment is over**
- **Ask the management about the "Finders Fee" bonus! Earn \$\$\$\$ off of the rent of your booth.**
- **Parking!!! Please move your car after you have unloaded so our customers can find a place to park**
- **Please keep the isles clear of your items so our after school helpers can do the vacuuming!**

**REMEMBER:** each vendor is responsible for 2 (TWO) four hour shifts per month. If you cannot work your time, you are responsible to pay for the fees owed, so we can pay another vendor to work your time. We are staying very busy and **MUST** have at least two floor workers on each and every shift. **If you are a "no show" for your scheduled time you will be charged the \$15 per 4 hour shift, PLUS a \$10 no show fee.**

**When you come in for your work shift there are two new documents we would like you to read.** One is about using your time while working and the other is what to look for to help spot shoplifters.
