The store will make sales signs for your booth if you wish, or you can. We do ask that you let us know and sign up on the sheet next to the cash register. You are also responsible for letting us know when you take you sale off and crossing off your info on the sale sheet. If you only want to have certain items to be on sale you will need to mark them down or attach a sale tag to them with a percentage off on the tag. We do have "sale tags" if you want to have a few.
