UPSTAIRS VENDORS! Please do not put your sold or layaway items in the consignment area on the west side of the room. It is very unfair to the consignment vendors to have their items blocked by those items. I know it is hard to have those items left in your booths, but we are full, and I ask that you be considerate of others.

PLEASE tag all items in your booth. We are having items come to the front with no tags.

TAGS=MONEY!!! If an item is not for sale, please tag it with your number and NFS (not for sale).

We think we are having someone or "someone's" removing tags. Please, keep an eye on your items for missing tags and retag them. I know it is a pain but it's also difficult for the staff to get hold of you for a price.

We have new and newer vendors, (and because those of us that have been here longer forget) so here are some reminders for all of us dealing with contractual items:

- **Please keep your items within the booth parameters. When items are outside the booth, they become a tripping hazard and you run the risk of the furniture cart damaging them**
- Just a big reminder about tags, your vendor number on the top, brief description of the item in the center, and price on the bottom. Hang tags only, **no sticky tags, please**. It is Ok to tape hangtags on wood or glassware, or to pin your tags on fabric items
- Rent is due on the 1st of the month, payable up to the 10th and late with a \$10 late fee after that date
- A thirty-day written notice is required when you are shrinking down or vacating your booth at the end of the month. The notice **MUST** be to us on or before the first day of the month you want to vacate. For instance, if you want to vacate at the end of **July**, we must have the notice no later than **July 1**
- When you vacate a booth, it is your responsibility to vacuum and dust it. It is also your responsibility to keep your booth clean, safe and in a condition that allows complete access to customers and staff
